Russian nationals may continue applying for non-immigrant visas at any U.S. embassy or consulate where they can obtain an appointment." Please view the State Department's website for all U.S. embassies and consulates worldwide at usembassy.state.gov. Click on the link for the U.S. Embassy or U.S. Consulate location (i.e., where they plan to apply for the J-1 visa) and follow the instructions provided; the student should contact the U.S. Embassy or U.S. consulate if they have questions regarding the visa application process or to set up an appointment in advance of traveling to that country. Please note that visa issuance is at the sole discretion of the U.S. consular officials reviewing a foreign national's visa application. The processing of all visa applications is done on a case-by-case basis; therefore, the time of visa processing varies.
